

Belvidere – Boone County Planning Department Data License Agreement

The City of Belvidere and Boone County, having jointly formed the Belvidere – Boone County Planning Department and the Belvidere – Boone County Geographic Information System (GIS), hereby grants to _____(Name of Licensee, herein referred to as Licensee), a one year license from the date of execution by Belvidere and Boone County to use, in accordance with this agreement, the Belvidere-Boone County GIS data.

NO WARRANTY: Belvidere & Boone County provide the geographic data “as-is.” Belvidere & Boone County make no guarantees or warranties concerning the accuracy of information contained in the geographic data. Belvidere & Boone County make no warranties, express or implied, as to any other matter whatsoever, including, without limitation, the condition of the product, or its fitness for a particular use. The Licensee acknowledges and accepts the limitations of the data, including the fact that the data is dynamic and is in a constant state of maintenance, correction, and update. The burden for determining fitness for use lies entirely with the user. Although these data have been processed successfully on computers of Belvidere and/or Boone County, no warranty, express or implied, is made by Belvidere or Boone County regarding the use of these data on any other system, nor does the fact of distribution constitute or imply any such warranty.
